



PROCEDURE FOR REGISTRATION BY MEMBERS OF OTHER PROFESSIONAL ACCOUNTING ORGANISATIONS (PAOs) TO WRITE THE ICAG EXAMINATIONS

(ICAG EXAMINATION FOR MEMBERS OF OTHER PAOs)

Members of other PAOs who qualify under subsection 5 of section 14 of Act 1058 will follow the following procedures to enable them to write the ICAG examination.

1.0 Student Registration:

- {i} Visit **sms.icagh.org** (Student's Portal) to register for the Studentship Registration Number (SRN). The six-digit number generated serves as the Student's ID and shall be required for all transactions with the Institute.
- {ii} Besides other requirements, the registration application should have the qualifying transcript uploaded on the student's portal.
- {iii} The Institute would approve the online application.
- {iv} Members of other PAOs shall pay the registration and subscription fees of GH¢330 and GH¢330 (total of GH¢660), respectively, for the year 2024.

2.0 Exemptions

Members of the other PAO bodies may apply for exemptions for all subjects that will not be registered for examinations. After the Institute approves the exemptions, the student pays for them before registering for the examinations.
